**RONALD O. LOVERIDGE.** Ronald O. Loveridge is a long time professor of political science at UC Riverside, is Co-Chair of the Solar Valley Consortium, and is a former local elected official, with 19 years as Mayor of Riverside and 14 years as a Council member. He was President of the League of California Cities (2004) and President of the National League of Cities (2010). He is currently on the Board of the National Civic League Board and a Fellow in the National Academy of Public Administration. He is Vice President of the Ontario International Airport Authority, President of the Friends of the California Citrus Park, President of the Civil Rights Institute of Inland Southern California, and on the Board of Directors of the Coalition for Clean Air.

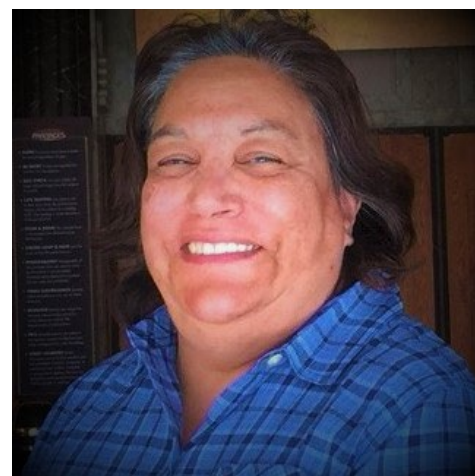
